Dear Senator Gold,

We, the undersigned faith communities and organizations, write to express our support for Bill C-15, an Act respecting the United Nations Declaration on the Rights of Indigenous Peoples. More specifically, we would appreciate expedited passage of the Bill (since it has so overwhelmingly been approved in the House and now passed Second Reading in the Red Chamber and has long been under pre-study by the Standing Senate Committee on Aboriginal Peoples.) We hope you will ensure that Third Reading debate and passage takes place before the summer recess, in order to receive Royal Assent in a timely manner.

As you are aware, Bill C-262 died in the Senate before the 2019 federal election. We were extremely disappointed when this took place, so ironically, on National Indigenous Peoples Day. It is past time to turn this sad story of prevarication around, moving towards right relationships with Indigenous Peoples of this land.

Bill C-15 is a critical step toward reconciliation with Indigenous peoples. Call to Action #48 of the Truth and Reconciliation Commission counseled all faith groups in Canada to formally adopt and comply with the principles, norms and standards of the *Declaration* as a framework for reconciliation. In this spirit, our support for Bill C-15 is an expression of our commitment to reconciliation with humility. It is part of wider efforts by faith communities to decolonize our minds and hearts, work against racism, and develop just relationships.

Implementation of the *Declaration* will require the federal government to undertake substantial consultations with Indigenous rights holders and organizations towards the development of an Action Plan. Faith communities commit to monitoring this process with care. We urge you to complete the important first step by passing Bill C-15, without amendment, and without any delay.
